Jagannath Barooah College (Autonomous) invites sealed tenders with a validity period of 180 days in prescribed form affixing non-refundable court fee stamps of Rs. 8.25 (Rupees Eight and Paise Twenty-Five) only subsequently to be drawn-up in printed PWD “F-2 form” from duly registered contractors of APWD (building) for the works detailed below. Detail of the work and the tender documents will be issued in the Office of the Technical Supervisor, J. B. College from 06-07-2024 to 13-07-2024 during 10:00 am to 4:00 pm against the payment of fee through prescribed instrument.

Terms and conditions:

1. Tender papers may be submitted in the drop box kept in front of the Office of the Principal up to 1:00 pm of 15-07-2024, and opened on the same day at 3:00 pm in the office of the undersigned.
2. Bid security is to be deposited in the form of Bankers Cheque/Demand draft only drawn in favour of the Principal, J. B. College, payable at Jorhat. Bids without requisite bid security shall be summarily rejected. Cost of tender documents may be paid digitally in the receipt counter at the College office or in the form of Bankers Cheque/Demand draft in favour of the Principal, J. B. College, payable at Jorhat.
3. Rates should be quoted on flat percentage basis as at par/above/below the schedule of rates under C.P.W.D. DSR for the year 2021 (CIVIL) (including all taxes, royalties, duties, octroi, excise, freight, work contract tax applicable in the state et. whatsoever from time to time).
4. The tender document shall be submitted in two parts as follows:
 - a. PART-1: This packet shall contain the Technical Bids comprising NIT, testimonials, other supporting documents, and any other relevant document the tenderer wish to submit duly signed with official seal etc. This shall be marked as ‘TECHNICAL BID’, followed by the short NIT number and name of the work and properly sealed. The bid security to be put inside the ‘TECHNICAL BID’ in a separate sealed envelope.
 - b. PART-2: This packet shall contain the Price Bids comprising the price against the tender. This shall be marked as ‘FINANCIAL BID’, followed by the short NIT number and name of the work and properly sealed.
5. The issue of tender paper to a contractor does not automatically mean that the tenderer is considered qualified for the price part of the bid. Qualifying criteria stated above is for participation/issue of tender documents only.

6. The Technical Bid shall be opened first on the above-mentioned date and time and the Financial Bid of only those bidders who qualify in Technical Bid shall be opened on the same date. Tenderer or their authorized representative should be present at the time of opening of the tenders along with original documents submitted with the technical bid. Absentee's queries will not be entertained.
7. Contractors must furnish documentary evidence showing execution of similar nature of works during the last three years.
8. The contractors must submit up-to-date copies of registration certificate (APWD Building) for the year 2024-25, GST, EPF, Caste Certificate, PAN card, ITR of last 3 years, Labour license, Partnership deed/Power of attorney in case of Proprietorship firm duly attested by self.
9. Documents submitted should be legible.
10. If for any reason the last date of issuing/submitted tender papers is a declared holiday/bandh, tenders will be issues/received/opened on the next working day.
11. The undersigned will be the sole authority to accept or reject any tender without assigning any reason thereof.
12. For all clarifications regarding site conditions, items of works or any other related queries, the tenderers may contact the Technical Supervisor, J. B. College during office hours.
13. The short NIT will be a part of the bidding document/contract agreement.
14. Other details can be seen in the tender document.
15. The payment to the contractors for the above tenders of works will be made subject to the availability of fund.
16. Safety norms as stipulated by the relevant Government authorities for construction activities must be strictly followed.
